Key trading statistics for May 2024

- May 2024 saw the highest average daily volume (ADV) traded in LME Copper since January 2015, at 192,699 lots.
- Total LME ADV from 1 January to 31 May 2024 was up 33% across all LME metals compared to the same period last year, with LME Nickel ADV up 82% yearon-year.
- LME Copper options open interest rose to an 11-year high and LME Aluminium options to a 6-year high at the end of May.


