LME launches CBAM consultation and broader sustainability discussion paper

We recently launched a consultation paper on the proposed integration of the EU Carbon Border Adjustment Mechanism (CBAM) requirements into the LME rules to support the aluminium market and value chain in implementing this pivotal environmental policy. Alongside this, our discussion paper seeks views on a range of proposals to drive forward initiatives that underpin the global transition to a sustainable economy.

Warranting and trading of Russian metal

In response to recent UK and US sanctions in respect of Russian metal, we issued a market notice on the measures introduced to comply with them. We subsequently issued a notice detailing some refinements to our approach, with the aim of ensuring fairness, reducing administrative burden and facilitating the circulation of globally usable metal without compromising the protection of our market from potential breaches of UK sanctions.

LME data highlights

- Average daily volume (ADV) in 2024 up to the end of April was 697,307 lots, up 35% compared to the same period in 2023.
- Overall 3M LMEselect volumes in April saw the third and fifth highest trading days on record.
- LME Steel Scrap CFR Turkey (Platts) had a record month in April, with ADV of 6,139 lots.
- In April, LME Zinc saw the highest monthly ADV since April 2018 at 129,803 lots.
