

Year-to-date LME Steel Scrap CFR Turkey (Platts) futures have traded 4.38 million metric tonnes (mt), already overtaking the 4.31 million mt traded in 2022. At the current rate we are looking to soon surpass the all-time annual trading record of 4.85 million mt set in 2018.
