#LMEAtoZ

Here we explore some of the common, and not-so-common, terms used by LME market

participants. This month we look at some key terms beginning with "R".

Refinery – A processing plant usually associated with a smelter that produces high purity metal.

Ring – The LME Ring is the circle of seats on the LME trading floor which members occupy when trading via open outrcy. More commonly the term is used to describe the periods of trading which are broken down into five-minute sessions for each metal.

Ring dealer - LME Category 1 Member firms that have the exclusive right to deal in the Ring.

Roll – A carry transaction, whereby an open position is 'closed out' and replaced with a similar position for a prompt date further ahead.
