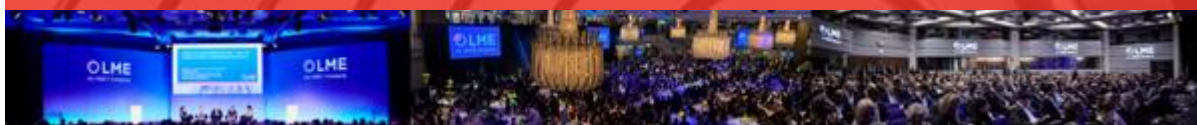

Ferrous new initiatives and updates

We are delighted to announce the launch of a number of new initiatives to support our ferrous contracts:

- We have made 15-minute delayed LMEselect bid-offer quotes for steel scrap, rebar and FOB China HRC steel futures freely available on LME.com. The [data](#) can be found in the intraday prices tab of each relevant contract.
- We have replaced our existing Ferrous Liquidity Provider programme with two new programmes designed to support the momentum and recent growth in volumes across our steel suite, representing a significant increase in investment in these markets by the LME.

- To further support the development of on-screen liquidity, we have introduced a new liquidity window on LMEselect for our LME Steel Scrap CFR Turkey and LME Steel Rebar FOB Turkey contracts, taking place daily 16.00-16.30 UK time.
