# Action Plan to strengthen and enhance our markets – update

Last month we updated the market on coarse nickel powder as a potential deliverable and received another fast-track nickel brand application for GEM-NI1 from Jingmen Gem Co.

We also announced the introduction of a new dynamic risk-based methodology to calculate the minimum size of the default fund.

Watch out in the coming weeks for updates on Closing Price methodology and off-warrant stock reporting.



#### LMEpassport – two years old

It is just over two years to the day since we launched our digital certificates of analysis (CoA) and sustainability credentials register, LMEpassport. The platform is now used by 219 LME-listed brands to share their sustainability data and achievements, while on the physical side, almost 2.5 million CoAs have been uploaded by warehouses and producers.

#### **Trading**

- Futures market open interest (MOI) is currently at over 1.7million lots, a 17-month high.
- LME Steel Scrap CFR Turkey (Platts) scrap recently hit 5 million tonnes for the

year (a record!) beating the previous 12-month high of 4.89m tonnes set in 2018 - and it is still only September.

- Monthly third-Wednesday volumes in August meanwhile were strong again breaking 18,000 lots for the second time ever in a single month.
- And last but not least, LMEselect 3M lead traded a record 13,448 lots on 1 September 2023, overtaking the previous record of 13,309 set back in October 2015. Lead MOI cleared 150,000 lots for the first time since November 2019 too.
